#### **Open the Meeting and Roll Call**

## Volunteers for Appointment/Reappointment to Planning and Zoning Boards

- Pier D'Aprile
  - Master plan
    - Wants to take a more in-depth look at the master plan through the lens of affordability, availability, and growth/development
      - "These are macroeconomic issues... We have a crowding of housing we've never experienced before."
    - Believes in balancing the preservation of Warner's rural character with healthy growth and change
  - Experience
    - Participated in and led a number of committees across the business world
    - 2 condominium associations
  - Experience and town meetings
    - Has read notes and minutes from land use boards and the select board
    - Attended zoning board meetings for a case involving personal property
      - Does not feel that this will be a conflict of interest and would recuse himself if necessary
    - Attended meetings of the Housing Advisory Committee
  - Code of Conduct and guidelines
    - "I think difference of opinions... help make things stronger."
    - "When you have professionals, that's what they do- they respect each other."
    - Has prior experience talking through difficult situations in the business world
  - Commitment to attending meetings
    - Full time resident, semi-retired
    - Able to commit to attending meetings

- Seeking reappointment
  - Has been involved in the Zoning Board for many years
    - "I'm interested in this town... very much so."
    - Enjoys being involved in the Zoning Board
- Very seldom misses meetings
- Impartiality
  - Has recused herself in the past when conflicts of interest arise
- Noted that many members of boards up for reappointment were resistant to the new interview process
- Also noted the importance of finding out why highly qualified people choose not to continue serving on boards

  - Didn't feel that the questionnaire provided by the board was problematic despite seeking reappointment

• Attendance

- Committed to attending meetings
- Served on the ZBA for slightly over a year
  - Feels that the work is difficult, but important
  - "I'm not always happy with the way I have to vote, but it's not about me. It's for the good of the town."
- Has already attended training through the state
  - Balances knowledge of RSAs with compassion for those bringing cases before the board
  - "I don't have to deal with the consequences of a vote. The person I voted yea or nay to does, and that weighs on me."
- Has attended meetings of other boards and committees as well despite a demanding work schedule
  - "I'd love to be here for all the meetings, but I go to the ones I can."
- Spearheaded initiatives to make site visits for previous ZBA cases

## Tax Collector- Request for Hiring a Deputy Tax Collector

- Deputy can take on the role of Tax Collector in an emergency
- Tax Collector appoints a deputy with the approval of the board
- Compensation for the deputy tax collector must fall within what has already been budgeted
- Further discussion to occur regarding online tax payment at the next board meeting
  - This would be an additional expense, although not necessarily a substantial one (\$1,500 \$2,000)

## **Zoning Board Minutes**

- The Zoning Board is requesting minutes that are highly detailed and nearly verbatim
- However, detailed minutes are expensive and time-consuming
  - Beneficial, but costly
- The current minute-taker for the ZBA can spend as many as 20 hours on one set of minutes
- Voice-to-text is a strong possibility
  - Devices exist to automatically generate transcripts and summaries of audio
- Better recordings can be generated with additional microphones for the Owl device
  - Microphones for meeting participants are also a possibility
- Minutes can be a burnout-inducing task, and many people who previously took minutes no longer have any desire to continue doing so

#### **Other Business**

- The YouTube channel is linked on the town website
- An official town Facebook account is being researched
  - To promote town events and other positive news in Warner
- Designated office hours for Select Board members to have open discussion with the public
  - Opportunities for face-to-face interaction with the board outside of formal meetings
  - Scheduling may prove difficult
- Building permit process
  - Issues regarding whether a surveyor can be required
  - If properties aren't surveyed, they run the risk of noncompliance with setbacks
  - Potential for online building permits
