

# **Warner Board of Selectmen**

Meeting Minutes Wednesday, April 6, 2011 APPROVED

## 1. Website

The Selectmen made a list of goals for the website:

- Ease of access e.g. navigation.
  - Is easy to keep up to date allows users to maintain certain information.
  - Creates a positive impression of Warner for visitors, especially potential residents and businesses.
  - Personalize the department pages.
  - It is a dependable, timely source for municipal information.
  - Is visually comfortable.
  - Has the ability to archive and search municipal records such as meeting minutes.
  - Communicates Town activities, information, etc. via calendar, email, social media, etc.
  - Facilitates better awareness between Town boards and departments.
  - Links to area organizations, businesses and attractions.
  - Improved contact information for Town officials and departments.

The Town Administrator recommends allowing the Selectmen's secretary and the Land Use secretary, at the very least, the ability to upload information to the website.

At their next scheduled work session on April 19<sup>th</sup> the Selectmen will talk about websites that they have visited and noted their likes and dislikes.

## 2. Manifest

Selectman Hartman **MOVED** to authorize the Selectmen to sign manifests and order the Treasurer to sign Payroll check numbers 1188-1212 in the amount of \$29,231.63 (includes 15 direct stubs) and Accounts Payable check numbers 45684 -45692 in the amount of \$48,631.27. Selectman Karrick seconded the motion; all were in favor, the motion **PASSED**.
