Hi Kimberley,

I don't believe I ever spoke to you about RSA 80:52-c but I can tell you that RSA 80:52-c is listed on the Warner website document/procedure/policy page under Warrants Articles - Adopted at Town Meeting and the Town did not adopt it. The list is provided by DRA because they keep track of the RSA's the Town adopts. I read RSA 80:52-c and am confused. The text in the RSA reads as if the governing body, Select Board, can give their approval and the RSA is adopted. That contradicts the necessary adoption at Town Meeting as stated on the list from DRA.

I would suggest contacting DRA and or NHMA.

I am not aware of how you are accepting credit cards in the Tax Collector's office. I know when I was working on setting up the machines, my experience included contacting Interware for assistance to connect the account, software, etc at the location where the credit card machine was to be used. The cc machine was not going to be set up in my office so I did not set it up. I know Kathy took everything I had for the hand held cc machine for Varick to set up at the Transfer Station. I told her all the set up information that I had learned. She and Varick listened and took the machine to the Transfer Station to set-up. I believe Varick informed Kathy that he had set up problems and had to stop that installation because administration authority was needed.

I would also suggest talking to Michele about using the cc machine. Security and posting fees are a few things she can advice you on. I think there was a cc policy or procedure as well.

You may want to also look into adopting RSA 80:52-a Prepayment of taxes. That is shown as not adopted but I believe people do it.

Subject: Payment by Credit Cards

Gentlemen,

As requested, the Tax Collector's Office began offering payment via credit cards in November. So far, 4 property owners have taken advantage of that option.

Since then, Judy pointed out that **RSA 80:52-c** has not yet been adopted, and therefore we actually shouldn't be offering that payment option quite yet. Here is the RSA:

**CHAPTER 80
COLLECTION OF TAXES
Miscellaneous Provisions
Section 80:52-c**

80:52-c Electronic Payment. – The governing body may authorize the municipality's treasurer or other appropriate municipal official to accept payment of local taxes, charges generated by the sale of utility services, or other fees or charges by use of a credit card, debit card, or such other means of electronic transaction as approved by the governing body. Any municipality may add to the amount due, in addition to any penalties and interest payable, a service charge for the acceptance of the credit card, debit card, or such other means of electronic transaction as approved by the governing body. The municipality, at the time of billing, shall disclose the amount of the service charge.

In an upcoming meeting of the Select Board, please officially ***"authorize the Tax Collector's office to accept payments of local taxes, fees and charges by use of a credit card, until rescinded."***

Once you do that, meeting minutes showing that 80:52-c has been adopted can be forwarded to the DRA.
